

Thank you for your email requesting information about the Deputy Police and Crime Commissioner (below). I can provide the following information:

1. The Deputy Police and Crime Commissioner is appointed on a salary of £56,571.
2. The Deputy PCC position is full-time (37 hours / week).
3. The Deputy PCC has attended the following public events since her appointment on 10 April 2013. (You clarified *public events* as events which any member of the public could theoretically attend. This would include council meetings, community group events, church fetes etc, but not private meetings between the DPCC and an individual member of the public, nor a private meeting between the DPCC and an organisation – even if they took place in a public place like a café).
