Response: Tables below demonstrate projects that have been paid for via the following Funding Streams:

- West Yorkshire Police and Crime Commissioners (PCC) Victim, Witness and Criminal Justice Delivery fund provided by the Ministry of Justice (MoJ). PCCs became responsible for commissioning some support services for victims of crime (including rape and sexual assault) in their local areas from 1 October 2014 (previously this was administered by the MoJ in central government).
- The Safer Communities Fund was launched to help voluntary, community groups, charities and partners keep their community's safe and feeling safer. Grants are awarded in line with the outcomes and priorities set out in the Police and Crime Plan. The Safer Communities Fund is financed from monies recovered by West Yorkshire Police under the Proceeds of Crime Act (POCA). The Proceeds of Crime Act 2002 lets us confiscate or recover the proceeds of crime from a criminal.
