Perpetrator Programmes Funding

August 2020



Background

The Home Office is seeking to award grant funding to Police and Crime Commissioners (PCCs) in England and Wales to support the adoption of the domestic abuse perpetrator focussed programmes in their area. They are looking to award up to £5 million across England and Wales for the 2020-2021 financial year.

Introduction

The Home Office are looking for bids from PCCs who wish to introduce innovative approaches to tackle domestic abuse by working with perpetrators in their geographic area.

PCCs should be the lead partner but clear arrangements (financial and otherwise) for local partners involvement should be in place. These arrangements should take in to account the collaboration and joined-up working necessary for delivering the activity.

Match funding and sustainability

Bids should cover a six-month period of delivery between October 2020 and March 2021. Bidders should also be committed to providing match-funding to deliver an additional six months of the activity beyond the end of the financial year from April 2021 to September 2021.

The Home Office will consider investment already made in delivering interventions during the first half of 2020 as part of any winning submission, but this is no guarantee that income will be provided because each submission will be evaluated on its own merits. Funding will be paid in arrears in two instalments at the end of December 2020 and the end of March 2021. The Home Office will require monitoring and progress reports against project outputs and outcomes before funding is released.

Bids should outline the sustainability of project activities, demonstrating how the impact is intended to last beyond the funding period.

For example, bids should demonstrate how approaches could be rolled out across a wider area or develop tools that have the potential to be rolled out more widely, such as training products or learning materials. Bids should include details of match-funding to sustain the programme for a further six months beyond the end of the financial year (2020/21).

Outcomes

Bids must demonstrate how this funding will be used to improve outcomes for perpetrators of domestic abuse with the ultimate aim of reducing reoffending and protecting victims and survivors of domestic abuse. The Home Office are specifically looking for:

Sustained reduction of abuse

- Behaviour change through the stabilisation of related needs, e.g. mental health and substance misuse
- Reduction in risk posed by the perpetrator

In addition, bids must demonstrate how they contribute to one or all the following broader systemslevel outcomes:

- Improving the availability of support targeted at perpetrators of domestic abuse
- Improving the evaluation of perpetrator-focussed interventions
- Improving collaboration and joint-working in the provision of perpetrator interventions/protection of victims

Essential criteria

- 1. Bids must meet required outcomes.
- 2. Match-funding must be provided for a minimum of six months from April 2021.
- 3. Bids must be of additional activity not currently provided.
- 4. Evaluation plans must be submitted.

Need and Additionality

Proposals must be for additional activity not currently provided for through service provision funded by another national or local commissioning body e.g. PCC, CCG, local authority. The bid should clearly demonstrate that there is a lack of provision for targeting high harm, high risk perpetrators of domestic abuse. We will, however, consider bids that seek to build on existing work. In these cases, bidders should demonstrate how the service will be expanded and clearly demonstrate the need for additional funding.

Bids should be based on an assessment of the needs of domestic abuse perpetrators through an analysis of available evidence and data. We recognise that domestic abuse remains a largely unreported crime and that the under-representation of some groups of victims in official statistics and service provision is itself a source of evidence. In cases where empirical data is still emerging, the lived experiences of victims and perpetrators of domestic abuse also provides a valuable source of evidence

Further requirements

Bids should take in to account the diverse needs of victims and perpetrators of domestic abuse. Bids should reflect how the proposed activity is designed to address perpetrators and benefit victims from diverse backgrounds, including those from BAME, LGBTQ+ and disabled communities.

Bids must comply with Home Office financial guidelines (further details are contained with the bidding documentation).

Bids must demonstrate how the project is scalable, in case the organisation is awarded less funding than originally bid for (and how the scaling options would affect what could be delivered under the proposal).

In making a final decision on allocation of funding, the Home Office will ensure that an appropriate distribution of projects is funded.

Further Bid information

PCCs working with local partnerships may submit more than one bid, as long as they are registered separately, but Bidders may not receive separate grant funding to deliver the same set of interventions.

The activity should <u>not duplicate or undermine current provision</u>. The fund is primarily aimed at introducing new programmes in partnership with local organisations. However, the Home Office will also consider bids that seek to build on existing work provided if bidders can demonstrate how the service will be expanded, for example by extending geographical reach, targeting different cohorts, or adding to new elements to the programme.

Each PCC bid must be for a minimum of £200,000 and maximum of £1,000,000 for this financial year.

In making a final decision on allocation of funding, the Home Office will ensure that an appropriate distribution of projects is funded.

To ensure diversity of funding and the greatest level of support, the Home Office may scale back top scoring bids in line with the scalability details provided. All bids that do not include the ability to be scaled (and an assessment of how the scaling options would affect what could be delivered under the proposal) will be rejected.

Bids should be submitted in pounds sterling and be inclusive of expenses and inclusive of VAT.
